

## **Stop corruption and human rights violations**

**An elite of power is committing heinous crimes against humanity, unbeknownst to ordinary citizens. Fampo<sup>1</sup> is an organisation which struggles to get the truth out and stop the corrupt networks.**

This includes the sinister story of the cancer industry. In his book *World Without Cancer*, G. Edward Griffin marshals the evidence that cancer is a deficiency disease – like scurvy or pellagra – aggravated by the lack of a vitamin, vitamin B17. Not only can the vitamin prevent cancer, but it has been used with good results in cancer therapy.

This is not approved by orthodox medicine, but labelled fraud and quackery. In *World Without Cancer* Griffin explains how fraud has been used to sabotage research demonstrating the usefulness of B17 in cancer therapy. The consequence is that billions are spent each year on research and other billions taken in on the sale of cancer-related drugs, while millions of people die needlessly. There is a word for this – genocide.

In the book *Wall Street and the Rise of Hitler* (see [www.fampo.info/history.html](http://www.fampo.info/history.html)), historian Anthony C. Sutton documented how the financial elite on Wall Street was deeply involved in the rise of Nazism and Hitler's takeover in Germany. Sutton cites several documents which show that the financing of Hitler was done by subsidiaries of American companies, among them Henry Ford in 1922, followed by I.G. Farben and General Electric in 1933 and payment to Heinrich Himmler from Standard Oil of New Jersey and a subsidiary of I.T.T. until 1944.

American multinational companies profited on Hitler's armament in the 30s and at least until 1942. The same international bankers used their influence to hide their collaboration when the war was over. In another book available on the internet, *George Bush: The Unauthorised Biography*, Webster Griffin Tarpley and Anton Chaitkin document that former U.S. president George Bush Sr.'s family was involved in Hitler's takeover.

In an article (see [www.fampo.info/international.html](http://www.fampo.info/international.html)) you can read about how Great Britain sponsors terrorism. Several groups banned by United States are headquartered in London. Several countries have protested against Britain's harbouring of terrorists. This demonstrates that the "war on terror" is a cruel hoax. Fampo documents that Norwegian authorities violate human rights in a great scale.
